MINUTES OF BUSINESS SESSION

Matters concerning MCTA Hqrs/Branches (Amendment of the MCTA Constitution)

Articles/Sections of the MCTA Constitution are amended as follows:

1. **Article IV: Membership (1)** : “Any person working in the *Government Colleges* or *College level Government Training Institutions* of Mizoram under the University Grants Commission (UGC) norms as a *Lecturer/Reader/Professor/Principal* may become a member of MCTA”
2. **Article VII: Terms and Quaram (2)** : “The terms of the Office Bearers shall be 2 (two) years. *If elections are not held within three months of expiry of the term, the Office Bearers would cease to be duly elected representative of the Association*”
3. **Article XI: Condolence (4)** : “Each MCTA member shall contribute *Rs. 300.00 (Rupees three hundred)* annually to meet the necessary expenditure for condolence gift”
4. **Article XIII: Miscellaneous (3) Auditor(s)** : “*The accounting year of MCTA is 1st April to 31st March. The headquarters' executive shall appoint annually two auditors to audit the Association's Accounts*”

Matters Concerning Government of Mizoram

1. The Mizoram Higher & Technical Education Service Rules be constituted and made it an organised service.
2. Teachers of Govt. Colleges be given privileges at par with officers of other Departments under Govt. of Mizoram regarding subscription of News papers and magazines.
3. All Government Colleges without bus should be provided with buses.
4. Let the MCTA Hqrs. pressurize the govt. of Mizoram to appoint contract basis Lecturers instead of Guest Lecturers.
5. Govt. of Mizoram be moved to take initiative for provincialisation of Kamalanagar Deficit College.
6. MCTA Hqrs. should take measures to assure that the ACRs of Lecturers submitted to the Directorate of Higher & Technical Education is available when required.

Matters concerning Mizoram University

1. In-service candidates be given preferential treatment by the MZU regarding admission into M.Phil/Ph.D programs.
2. Mizoram University be moved to prepare Question Bank for Under Graduate Courses.
3. College teachers on MZU duty be allowed to use their own vehicles and bill for the same.
4. Mizoram University authority be moved to increase/strengthen the staffs of Under Graduate Examination Department to expedite the process of UG Examination.
5. University authorities be pressurized to review the mode of payment of remuneration for evaluation and setting of papers.
6. University authorities be pressurized to engage only UG Teachers to set question papers for UG Courses.
