NOTIFICATION

In pursuance of Notification No. G.12017/6/2009-HTE dt. 25.11.2010 and as per a new nomenclature of College Teachers approved by the Government of India, the Governor of Mizoram is pleased to order fixation of the Pay of College Librarians *who were already in the Grade* as on **01.01.2006** as listed in the **Annexure** appended herewith in the Pay Band of ₹ **15,600-39,100/- with Academic Grade Pay of ₹ 6000/-(Stage-1)** w.e.f **01.01.2006** under **Para 5(a)(i)** of **Appendix-I** to **Clause 2.1.0** under **Schedule 2.0.0** of the UGC Regulation, 2010 adopted by the Government of Mizoram.
